Capital Levy:

\$716 per family p.a. (Compulsory levy, this is not Tax Deductible)

Voluntary Building Fund:

\$100 per family p.a. (Tax Deductible)

P & F Levy:

\$100 per family p.a.

Community Participation Levy:

\$200 per family p.a. (Rebate received after 10 points of **P&F supported activity**)

Years 4, 5 and 6 Camps:

Camp fees are charged over Terms 1, 2 and 3

Adjustments will be made in Term 4 once allowance is made for fundraising efforts and actual camp costs.

PAYMENT METHODS:

DIRECT DEBIT: This is the school's preferred method. Forms need to be **completed and returned to school by Friday, 27th January**. The first monthly payment will be deducted on **Friday, 3rd February**, and will continue on the 3rd of each month.

OTHER PAYMENT METHODS: BPay; BPoint (Credit Card), EFTPOS facilities available at the school office; or Cash

DISCOUNTS:

A 2.5% discount on school tuition fee and Capital levy will be granted if full payment of the annual fee is made by Friday, 3rd March 2023.

CONCESSIONS:

The school considers applications from families who are experiencing difficulties meeting the cost of fees, but does not grant concessions for fees that are in arrears. Families needing a concession must complete a **2023 Concession form as concessions do not continue automatically from one year to the next**.

The decision to grant a concession is made on the family's assessed ability to pay based on information disclosed by the family and nationally recognized poverty scales.

All families granted concessions are required to use the Direct Debit or Centrepay method of payment. Applications close on **Friday, 31st March 2023**.

ACCOUNTS IN ARREARS:

Payment of Term accounts should be finalized two weeks after issue, that is, usually during the fourth week of the school term. Accounts not paid by this time are referred to the School Principal for action including the use of a commercial collection agency. All debt recovery costs associated with such services will be passed onto families concerned.
